Introduction

For many businesses, the cost of energy is high, so improving their energy efficiency can be the key to remaining competitive. There has been growing recognition that an effective energy management system can help reduce energy costs and environmental impact.

ISO/TC 242 is the International Technical Committee responsible for developing standards on energy management. As a participating member of ISO/TC 242 (Energy Management), Singapore facilitates the consolidation of comments and process of consensus-building among the stakeholders in the National Mirror Committees and thus contributes to the international standards development work.

In addition to the publication of ISO 50001 (Energy management systems - Requirements with guidance for use) which helps organisations to systematically plan and manage their energy use, ISO/TC 242 has developed a suite of complementary energy management system (EnMS) standards which will guide organisations through the various stages of setting up an EnMS. These standards, which are adopted by Singapore, consist of:

- SS ISO 50002 (Energy audits Requirements with guidance for use)
- SS ISO 50003 (EnMS Requirements for bodies providing audit and certification of energy management systems)
- SS ISO 50004 (EnMS Guidance for the implementation, maintenance and improvement of an energy management system)
- SS ISO 50006 (EnMS Measuring energy performance using energy baselines (EnB) and energy performance indicators (EnPI) – General principles and guidance)
- SS ISO 50015 (EnMS Measuring and verification of energy performance of organisations – General principles and guidance)

Note: ISO 50001 was adopted as a Singapore Standard in 2011.

In supporting the implementation of SS ISO 50001, the above-mentioned standards provide guidance to help organisations institutionalise the policies, procedures, and tools to systematically track, analyse and improve energy efficiency.
