## **A) Notification of draft Singapore Standards**

### **Food**

#### **Revised**

#### **1. Code of practice for the processing and handling of quick frozen foods (Revision of CP 46: 1989)**

This standard is intended to provide guidelines for the processing, handling, storage, distribution and retailing of quick frozen foods in order to ensure food safety and to maintain the quality of the foods up to the time of final sale.

This standard is applicable to quick frozen foods of all types which have been subjected to the process of quick freezing and are offered for sale in a frozen state. It does not apply to ices, frozen milk and dairy products.

Potential users of the standard include food manufacturing establishments involved in the processing and handling of quick frozen foods such as factories and central kitchens.

#### **2. Hazard analysis and critical control point (HACCP) system for food industry – Requirements with guidance for use (Revision of SS 444 : 2010)**

This standard specifies requirements for a hazard analysis and critical control point (HACCP) food safety management system.

The requirements in this standard have been specified for use in auditing operational HACCP-based systems which ensure the safety of foodstuff during production, preparation, processing, manufacturing, packaging, storage, transportation, distribution, food services, retailing, and any other sector related to the food chain.

This standard also sets out the principles of the HACCP system and provides general guidance for the application of the system. It is recognised that the details of application may vary depending on the circumstances of the food operation.

This standard will replace SS 444 : 2010.

Potential users of the standard are food business operators that wish to design and implement an effective HACCP management system, regardless of type, size and product. They include users such as slaughter houses, factories, F&B outlets and logistics companies.

**B.1 Proposal for New Work Items**

**Information Technology**

**Technical Reference for national digital identity (NDI)**

This Technical Reference standardises the architecture, implementation and integration of NDI systems to ensure a secure, open and interoperable ecosystem.

Potential users include registration authorities, authentication service providers, digital signing providers and relying parties developing e-services that rely on NDI for various reasons (e.g. user authentication, digital signing, MyInfo integration).

**B.2 Review of Singapore Standards**

**Electrical and Electronic**

**Code of practice for earthworks in the vicinity of electricity cables (SS 576 : 2012)**

This standard applies to all works carried out in the worksite or in its vicinity where underground cables may be found. In addition to a safe system of work, it provides practical safety precautions to avoid damage to electricity supply cables in different situations, including works that involve excavation, ground penetration and earth moving operations by heavy machinery.

The standard is reviewed with the intention to update it.

Users of the standard include contractors, licensed cable detection workers, excavator operators, earthworks supervisors, transmission agent licensees, professional engineers and relevant government agencies (e.g. EMA).

## Frequently asked questions about public comment on Singapore Standards:

### 1. What is public comment?

Singapore Standards are established based on an open system which is also in accordance with the World Trade Organisation requirements. These documents are issued as part of a consultation process before any standards are introduced or reviewed. This important stage in the development of Singapore Standards is the Public Comment period. This mechanism helps industry, companies and other stakeholders be aware of forthcoming changes to Singapore Standards and provide them with an opportunity to influence, before their publication, the standards that have been developed by their industry and for their industry.

### 2. How does public comment benefit me?

This mechanism:

- ensures that your views are considered and gives you the opportunity to influence the content of the standards in your area of expertise and in your industry;
- enables you to be familiar with the content of the standards before they are published and you stand to gain a competitive advantage with this prior knowledge of the standards.

### 3. Why do I have to pay for the standards which are proposed for review or withdrawal?

These standards are available for **free viewing** at Toppan Leefung Pte Ltd and all public libraries. However, the normal price of the standard will be charged for those who wish to purchase a copy. At the stage where we propose to review or withdraw the standards, the standards are still current and in use. We seek comments for these standards so as to:

- provide an opportunity for the industry to provide inputs for the review of the standard that would make the standard suitable for the industry's use,
- provide feedback on the continued need for the standard so that it will not be withdrawn,

### 4. What happens after I have submitted my comments?

The comments will be channelled to the relevant standards committee for consideration and you will be informed of the outcome of the committee's decision and you may be invited to meet the committee if clarification is required on your feedback.

### 5. Can I view drafts after the public comment period?

Drafts will not be available after the public comment period.
