CODE OF PRACTICE FOR VERTICAL PLATFORM LIFT WITH ENCLOSED PLATFORM AND AUTOMATIC SLIDING DOORS

Objectives

This circular informs the industry of the following:

- (a) Publication of a new Code of Practice ("COP") for vertical platform lifts with enclosed platform and automatic sliding doors; and
- (b) Adoption of the COP as an acceptable solution for these lifts for the purpose of complying with the performance requirements for lifts under Fifth Schedule of the Building Control Regulations 2003.

Background

- 2. In recent years, BCA has observed a rising demand for vertical platform lifts with enclosed platform and automatic sliding doors, particularly in landed houses. As these lifts have enclosed platforms and automatic sliding doors, their operations are very similar to that of the conventional passenger lifts, which the general public is familiar with.
- 3. Although the platform enclosure in these lifts eliminates the risk of users getting caught in the gap between the platform and the lift shaft, it introduces new safety risks including lack of ventilation and communication in a mantrap situation. Other safety hazards include unintended car movement, fire risk, unintentional access to controller, obstructed emergency escape path, and lack of safe working platform and refuge space for workers if the design of the lift does not address these issues.
- 4. Such lifts cannot fully comply with both EN81-41 and SS550, which are acceptable solutions for vertical platform lifts (without full enclosure) and conventional passenger lifts respectively. Hence, currently, the Qualified Person for building plan (QP(BP)) and the Specialised Professional Engineer in the specialised branch of lift and escalator engineering (SPE) would submit an application for alternative solution to EN81-41 for these lifts, with proposed measures to mitigate the safety hazards introduced. BCA will then approve these applications on a case-by-case basis.





New Code of Practice for Vertical Platform Lift with Enclosed Platform and Automatic Sliding Doors

- 5. BCA has developed a Code of Practice (COP) to address the safety hazards, with reference to established standards (including EN81-41, SS550:2020). The COP aims to formalise the requirements that BCA is currently imposing on the applications for alternative solution for vertical platform lift with enclosed platform and automatic sliding doors. The COP specifies the minimum requirements for the installation, operation and maintenance of these lifts.
- 6. The COP will be an acceptable solution, described in the BCA Approved Document, for the purpose of complying with the performance requirements for the design and installation of lifts under Fifth Schedule of the Building Control Regulations 2003. If the lift is fully compliant with the COP, there will be no need for submission of an alternative solution for approval. Type examination certificates and reports shall be submitted with the PTO application.
- 7. Notwithstanding if there is any deviation from the COP in the design of a proposed lift, the QP(BP) and SPE will have to submit an alternative solution application for approval, with the following documents:
 - a. Schedule of Alternative Solutions with declaration by the QP and SPE:
 - b. Clause-by-clause compliance table against the COP, with reference to clauses in the established standards; and
 - c. Supporting documents (such as photos, videos, type examination certificates and reports)

Effective Date of Implementation of the Code of Practice

- 8. A six-month grace period will be given from the issuance of this circular. The developer, builder and qualified persons involved in proposed building works for which the first set of plans (building plans, structural plans or CD shelter plan whichever is earlier) is submitted to BCA **on or after 3 December 2024**, must ensure compliance with the COP, where applicable.
- 9. In the interim before 3 December 2024, to simplify the process for project parties who propose the installation of a vertical platform lift with enclosed platform and automatic sliding doors, the relevant SPE may ensure compliance with the COP and thereafter, declare such compliance in the alternative solution application, without having to list down the deviations from EN81-41 and the corresponding mitigations.
