### REMINDER: PUBLICATION OF ENFORCEMENT ACTIONS ON BCA WEBSITE

This circular seeks to remind the industry of the publication of enforcement actions on BCA's website for contraventions of the Building Control Act, the Building Maintenance and Strata Management Act, the Amusement Ride Safety Act, as well as their Regulations.

2. BCA is committed to ensuring high standards of safety and professional conduct within the Built Environment (BE) sector. The enforcement regime seeks to deter contraventions and take errant parties to task against unsafe practices and outcomes.

3. In this context, selected enforcement actions taken by BCA are published on BCA's website (<https://go.gov.sg/bca-enforcement>) to send a strong deterrent message and shape the behaviour of industry stakeholders, including service buyers.

4. The publication is updated on a quarterly basis and published information will remain on the website for a period of 3 years.
